InsurPac is one of the reasons why the Big I is routinely rated in Fortune magazine's top-25 list of most successful lobbying groups in Washington D.C. By pooling individual contributions, InsurPac helps elect candidates and re-elect members of the U.S. Congress who share the Big I's business philosophy. While contributions do not buy solutions to legislative debates, they do allow the Big I significant 'face time' with very busy elected officials to give us an opportunity to educate them.

InsurPac disbursed \$1.9 million to Congressional candidates in this past election and won 93% of the races that it supported. InsurPac has helped the Big I win on the following issues:

- stopped proposals from Congress to retroactively void exclusions in contracts and force insurers to pay business income claims for something that was never priced.
- advocated for legislation, including the Paycheck Protection Program, to support our agent members and their clients cope with the COVID-19 pandemic.
- secured a year-long extension of the National Flood Insurance Program.
- Exempted agents from a bill that passed the U.S. House that would require small businesses with fewer than 20 employees to file new reports on their "beneficial ownership" with the Treasury Department.
