InsurPac is one of the reasons why the Big I is routinely rated in Fortune magazine's top-25 list of most successful lobbying groups in Washington D.C. By pooling individual contributions, InsurPac raised \$1.2 million in 2021 to help elect candidates and re-elect members of the U.S. Congress who share the Big I's business philosophy. While contributions do not buy solutions to legislative debates, they do allow the Big I significant 'face time' with very busy elected officials to give us an opportunity to educate them.

The Big I has successfully fought against numerous tax increases in 2021:

- C-corp rate increase to 26.5% on income over \$5 million.
- Top individual tax rate increase to 39.6%, while lowering the income threshold.
- Increase on the top capital gains tax rate from 20% to 25%.
- Modification of the 20% small business deduction.
