### Dues Calculation

IIABW collects dues based on the number of licensed employees in the agency's main office and branches. Employees include all officers, owners, partners, producers, CSRs, etc. in the insurance and employee benefits departments. Employees who work 30+ hours per week should be counted as '1' and those who work under 30 should be counted as '1/2' (round fractions down)

Based on the information we have for your agency, we have computed your annual membership dues below. If any of this information is not accurate, please make the appropriate corrections and adjust your dues payment accordingly.

You can pay your annual dues in full by September 1<sup>st</sup> or pay it quarterly on Sept. 1, Dec. 1, March 1 and June 1. **We will automatically charge your credit card quarterly.**

We have also included a suggested amount for your firm's contribution to Big I PAC, your association's state political action committee which supports legislative candidates who support IIABW's political agenda of fair insurance regulations and taxes. Your contribution to the PAC is voluntary but is essential for IIABW to effectively represent your business interests at the state legislature. We are recommending contributions of \$75 per agency plus \$25 for each employee.

Dues payable by the member agency to IIAB local affiliates will be billed separately by the local affiliate.
